PUBLIC NOTICE**

REGARDING SPECIAL SERVICE PLAN 2021-02 – BY-LAW NO. 1789/2020

The Council of the Town of Altona has scheduled a public hearing at 227 10th Avenue NW on December 8, 2020 at 6:00 p.m. (*see reverse page for more details on how to attend*) to present the following special service proposal:

*The collection of solid waste, recyclable materials and compostable materials
and the operation of the landfill site.*

The Special Service Area to be taxed under this proposal will be all residential, commercial and institutional property within the Town of Altona. All vacant lots, farm property (Class 30) and railway property (Class 52) are excluded. The proposed per unit rates, effective January 1, 2021 are shown below. These rates are subject to annual increases as per the Special Service Plan.

Single and two family residences	\$195.00
Multiple family residences (apartment buildings with more than 2 suites)	\$195.00
Other Properties	\$195.00
Other Properties or Multiple family residences (that privately acquire commercial container services)	\$105.00

A written objection may be filed with the Chief Administrative Officer, at 111 Centre Avenue prior to the commencement of the hearing. At the hearing, Council will hear any potential taxpayer who wishes to make a presentation, ask questions or register an objection to the special service proposal.

All objections, written or verbal, must be filed prior to the adjournment of the hearing and must include the name, address and property description of the person filing the objection and the grounds of their objection.
